**SUBJECT:** Good Places to Learn - Stage 4 Funding Allocation

---

As a follow-up to the March 26, 2008 Memorandum (2008:B2) announcing education funding through the Grants for Student Needs for 2008-09, I am writing to provide you with information on the Good Places to Learn (GPL) Stage 4 allocations to boards. ***These allocations are conditional upon a future change to the 2008-09 GSN regulation, which is subject to approval by the Lieutenant Governor in Council (LGIC).***

In 2008-09, the Ministry is providing school boards with an allocation to support a further \$250 million to continue to address high and urgent renewal needs, and lacking or inadequate specialized spaces not funded in previous stages. This is in addition to the \$2 billion already allocated to boards through GPL Stage 1, Stage 2 and Stage 3.


#### **Stage 4 Allocation Calculation**

The allocation of Stage 4 allocations to boards is based on the following factors:

- The renewal needs of “eligible schools” is based on inspected facilities operating an elementary or secondary day school program, with ADE, as reported in Appendix C of the 2008-09 Estimates;
- Schools that have been recognized for funding through 2005 Policy Transitional and/or Prohibitive to Repair are not eligible schools;
- The portion of renewal needs for shared facilities, (shared either between coterminous boards or between panels), is based on the board’s share of the total On-the-Ground (OTG) capacity reported for the facility in Appendix C of the 2008-09 Estimates; and
- A number of allocation adjustments related to PTR funded facilities and a small number of other “technical” corrections (see **Appendix A**).

Each board’s Stage 4 allocation is approximately 12% of the 5-year (2003-2007) high and urgent renewal needs and program needs for eligible schools, less the sum of the Stage 1, Stage 2 and Stage 3 allocations, and the allocation adjustments (noted above). **Appendix B** provides the board-by-board Stage 4 allocations. Once approved by the LGIC, the Ministry will post the detailed calculation of boards’ Stage 4 allocations on the Ministry’s TPFR website (<http://tpfr.edu.gov.on.ca>).
