Subject: Changes to the Ontario Student Transcript and Secondary
 Provincial Final Report Card Templates

We are writing to share a technical update to the secondary provincial final report card templates and the Ontario Student Transcript templates to align with the release of PPM 167 regarding the online learning graduation requirement.

Secondary final report card templates now reflect all current graduation requirements, including adding the new online learning graduation requirement. These updated secondary templates are required for June 2022 reporting.

Samples of the updated secondary report card templates are now available at the ministry website:
<http://www.edu.gov.on.ca/eng/document/forms/report/card/reportcard.html>. Please work with your vendor to ensure updates to report cards are made in time for the respective reporting periods outlined above.

The Ontario Student Transcript templates have also been updated to reflect this new graduation requirement and is effective as of the 2021-22 school year. Schools and school boards can continue to order these templates from Lowe Martin Company Inc. (LMG), the approved provider for the bulk printing, manufacturing, inventory and distribution of Ontario Student Record and Ontario Student Transcript templates. Schools who have not used the online system before must register through LMG's Ministry of Education (MOED) webstore at: <https://moed.printreserve.com>.
