

# Parents' comfort levels with return to school are mixed, but they support funding for mental health, online learning and technology, and health and safety

Ontarians are almost twice as likely to say that spending on public education is more important than eliminating the deficit

Ontarians are nearly twice as likely to say that spending on public education is more important than eliminating the deficit. A majority of Ontarians would support or somewhat support restarting schools by having students attend in-person part time as well as online learning, and a majority support a mixed model of education including both in-person and online components. A strong majority say it is important or somewhat important for students at all levels to have real time interaction with their teacher and other students while learning online, and a majority support or somewhat support additional funding for a variety of purposes including increased transportation to schools, support for students with special education needs, and support for marginalized students.

A strong majority say it is important or somewhat important to consider the mental health needs of students, teachers and education workers when thinking of a return to in-person instruction in schools.

## Opening schools in September

- **Ontarians with children in the public school system have mixed views in terms of their level of comfort with students and staff returning to the school environment in September if the government decided to re-open schools** – Just over one in two Ontarians with at least one child in the public school system say they would be comfortable (18%) or somewhat comfortable (35%) with students, staff and education workers returning to the school environment if the government decides to re-open schools in September upon the advice of the Chief Medical Officer of Health. Over four in ten say they would be somewhat uncomfortable (25%) or uncomfortable (18%). Four per cent are unsure.
- **Just over one in ten Ontarians with children in the public school system say they are likely to keep their child home from school this coming September** – More than four in ten Ontarians with children in the public school system say they are likely (12%) or somewhat likely (32%) to keep their child(ren) home from school this coming September, while just over four in ten say they are somewhat not likely (22%) or not likely (19%). Fifteen per cent are unsure.

A majority say it is important for students at all levels to have real time interaction with their teacher and other students while learning online

- **Just over one in four Ontarians with children in the public school system would support a mixed model of education delivery including in-person and online delivery** – Over a quarter of Ontarians with children in the public school system would support (26%; 48% somewhat support) a mixed model of education delivery in which a portion of the student's education is delivered in-person and a portion delivered online, while just over two in ten would somewhat not support (12%) or not support this (nine per cent). Four per cent are unsure.

## Online learning

- **Over six in ten Ontarians say it is important for kindergarten to grade three students to also have real-time interaction with their teacher and other students when undertaking online learning** – A majority of Ontarians say it is important (64%; 21% somewhat important) for students in kindergarten to grade three to also have real-time/live interaction with their teacher and other students when undertaking online learning, while one in ten say this is somewhat unimportant (five per cent) or unimportant (five per cent). Five per cent are unsure. Residents of the GTA (58%) and the City of Toronto (59%) are less likely to say this is important than residents of Northern Ontario (72%).
- **A majority of Ontarians say it is important for students in grades four to eight to also have real-time interaction with their teacher and other students when undertaking online learning** – Nearly two in three Ontarians say it is important (64%; 27% somewhat important) for students in grades four to eight to also have real-time/live interaction with their teacher and other students when undertaking online learning, while less than one in ten say this is somewhat unimportant (four per cent) or unimportant (two per cent). Four per cent are unsure. Residents of Northern Ontario (72%) and Eastern Ontario (71%) are more likely to say this is important than residents of the GTA (58%) or the City of Toronto (57%).
- **Over half of Ontarians say it is important for secondary students to also have real-time interaction with their teacher and other students when undertaking online learning** – Just over one in two Ontarians say it is important (52%; 32% somewhat important) for secondary students to also have real-time/live interaction with their teacher and other students when undertaking online learning, while just over one in ten say this is somewhat unimportant (eight per cent) or unimportant (four per cent). Four per cent are unsure.

# SUMMARY



Seven in ten Ontarians who report having experience with online learning during the school year say the experience was positive or somewhat positive

- **A majority of Ontarians with a child or children in the public school system report their household did experience online learning during the current school year** – Ninety-two per cent of Ontarians with two or more children in the public school system report they have experienced online learning during the school year, while 80 per cent of those with one child in the system report experiencing this.
- **Two in ten Ontarians who report having experience with online learning during the school year say the experience was positive** – Just over two in ten Ontarians who report having experience with online learning during the current school year say the online learning experience was positive (21%; 48% somewhat positive), while just under three in ten say their experience was somewhat negative (21%) or negative (seven per cent). Three per cent are unsure.
- **Ontarians who report having experience with online learning during the school year mention direct interaction with teachers and one-on-one time in terms of what would have the online learning experience better** – Asked what would have made the online learning experience better, Ontarians who report having experience with online learning during the school year more often report direct interaction with teachers/one-on-one time (16%), followed by having more live classes/meetings/interactions with peers (13%), better internet connection/better technology/platform (11%), nothing (10%), more resources for parents and students/instructions on what to do (nine per cent), and more structured/organized (seven per cent).
- **Ontarians who report having experience with online learning during the school year more often report the online learning sometimes took place in real-time with other students** – Asked if the online learning took place live in real-time with other students, just over one in two say yes, sometimes (51%), while 32 per cent say it never took place real time, and 17 per cent say yes, all the time. City of Toronto residents are more likely to report it took place in real-time all the time (26%) than residents of Southwestern Ontario (eight per cent), Eastern Ontario (10%) or Golden Horseshoe West (11%). Ontarians with one child in the public school system are more likely to report this took place all the time (21%) than those with two or more children in the system (eight per cent).

- **One in four Ontarians who report having experience with online learning during the school year with real-time learning taking place at least sometimes say the experience was useful** – A quarter of Ontarians who report having experience with online learning during the school year and who report the online learning took place live in real-time at least sometimes with other students, say the real-time online experience was useful (25%; 53% somewhat useful). Just under two in ten say this was somewhat not useful (14%) or not useful (five per cent), and four per cent are unsure.

## Returning to in-person schooling

- **Just over one in four Ontarians would support restarting schools by having students attend in-person part-time in addition to online learning** – More than a quarter of Ontarians say they would support (26%; 45% somewhat support) restarting schools by having students attend in-person part-time, in addition to online learning, while just under two in ten would somewhat oppose (10%) or oppose this (nine per cent). Ten per cent are unsure.
- **Three in four Ontarians say it is important to consider the advice of healthcare professionals when thinking of a return to in-person instruction in schools** – A strong majority of Ontarians say it is important (76%) or somewhat important (19%) to consider the advice of healthcare professionals when thinking of a return to in-person instruction in schools, while two per cent say this is somewhat not important and one per cent say it is not important. Three per cent are unsure.
- **More than one in two Ontarians say it is important to consider the need for childcare in order to re-open the economy when thinking of a return to in-person instruction in schools** – Just over half of Ontarians say it is important (53%; 31% somewhat important) to consider the need for childcare in order to re-open the economy when thinking of a return to in-person instruction in schools, while just over one in ten say this is somewhat not important (six per cent) or not important (four per cent). Five per cent are unsure.

More than three in four Ontarians say it is important to consider the advice of healthcare professionals when thinking of a return to in-person instruction in schools

A strong majority of Ontarians say it is important to consider the mental health needs of children when thinking of a return to in-person instruction in schools

- **Three in four Ontarians say it is important to consider the educational needs of children when thinking of a return to in-person instruction in schools** – A majority of Ontarians say it is important (75%; 20% somewhat important) to consider the educational needs of children when thinking of a return to in-person instruction in schools, while two per cent say this is somewhat not important and one per cent say this is not important. Three per cent are unsure. Residents of Northern Ontario are more likely to say this is important (87%) than residents of the GTA (69%). Ontarians with two or more children in the public school system are more likely to say this is important (82%) than those with one child in the system (69%).
- **Over seven in ten Ontarians say it is important to consider the mental health needs of children when thinking of a return to in-person instruction in schools** – A majority of Ontarians say it is important (73%; 20% somewhat important) to consider the mental health needs of children when thinking of a return to in-person instruction in schools, while three per cent say this is somewhat not important and one per cent say this is not important. Three per cent are unsure. Residents of Northern Ontario are more likely to say this is important (85%) than residents of the GTA (64%) and the City of Toronto (69%), and women are more likely to say this is important (78%) than men (67%).
- **A majority of Ontarians say it is important to consider staff health and worker safety when thinking of a return to in-person instruction in schools** – Over three in four Ontarians say it is important (77%; 17% somewhat important) to consider staff health and worker safety when thinking of a return to in-person instruction in schools, while two per cent say this is somewhat not important and one per cent say this is not important. Three per cent are unsure. Women are more likely to say this is important (83%) than men (72%).
- **Ontarians more often mention nothing else or health and safety of all and following health and safety protocols in terms of considerations when deciding to return to in-person instruction** – Asked if there is anything else that should be considered when deciding about a return to in-person instruction in schools, Ontarians more often mention nothing else (24%), followed by health and safety of all/following health and safety protocols (17%), class size/reduce number of children per class/social distancing (10%), and up to date cases of COVID-19 infections/risk of second wave (five per cent).

Ontarians have a stronger intensity of support for more funding for those students with special education needs, for additional caretaking and cleaning supplies and for those students who are considered marginalized and/or need help.

## Support for funding

- **One in three Ontarians would support more funding for transportation to allow for more school busses** – One third of Ontarians would support (34%; 34% somewhat support) more funding for transportation to allow for more school busses, while over two in ten would somewhat not support (13%) or not support this (10%). Nine per cent are unsure. Residents of Central Ontario are more likely to support this (43%) than residents of the GTA (27%).
- **Just over one in two Ontarians would support more funding for additional caretaking and cleaning supplies** – Over half of Ontarians would support (53%; 33% somewhat support) more funding for additional caretaking and cleaning supplies, while one in ten would somewhat not support (seven per cent) or not support this (three per cent). Five per cent are unsure. Residents of Northern Ontario are more likely to support this (60%) than residents of the City of Toronto (49%) and the GTA (45%), and women are more likely to support this (59%) than men (45%).
- **One in two Ontarians would support more funding for technology including devices and equipment for students and teachers** – One half of Ontarians would support (50%; 35% somewhat support) more funding for technology, including devices for students and equipment for teachers and education workers, as well as increasing the infrastructure for those areas in the province with limited access. One in ten Ontarians would somewhat not support this (six per cent) or not support this (four per cent), and five per cent are unsure. Residents of Northern Ontario are more likely to support this (63%) than residents of the GTA (39%).
- **Just over one in two Ontarians would support more funding for those students with special education needs** – Over half of Ontarians would support (54%; 30% somewhat support) more funding for those students with special education needs, while one in ten would somewhat not support (six per cent) or not support this (four per cent). Seven per cent are unsure. Residents of Northern Ontario are more likely to support this (64%) than residents of the GTA (47%).

A majority of Ontarians are concerned or somewhat concerned about the pandemic's effects on students' mental health

- **Just over one in two Ontarians would support more funding for those students who are considered marginalized and/or need help** – More than one half of Ontarians would support (53%; 32% somewhat support) more funding for those students who are considered marginalized and/or need help to catch up due to the learning gap created by the pandemic, while under one in ten would somewhat not support (five per cent) or not support this (four per cent). Six per cent are unsure. Residents of Northern Ontario are more likely to support this (64%) than residents of the GTA (42%).
- **Over four in ten Ontarians would support more online learning professional development for teachers** – More than four in ten Ontarians would support (44%; 35% somewhat support) more online learning professional development for teachers, while over one in ten would somewhat not support (seven per cent) or not support this (seven per cent). Seven per cent are unsure.
- **Just over four in ten Ontarians would support more funding for increased online course options for secondary school students** – More than four in ten Ontarians would support (42%; 37% somewhat support) more funding for increased online course options for secondary school students, while under two in ten would somewhat not support (eight per cent) or not support this (seven per cent). Six per cent are unsure.
- **Just under four in ten Ontarians would support more funding to allow boards to be creative in their learning environment** – Close to four in ten Ontarians would support (39%; 38% somewhat support) more funding to allow boards to be creative in their learning environments, i.e. outside settings, while under two in ten would somewhat not support (nine per cent) or not support this (six per cent). Eight per cent are unsure. Residents of Northern Ontario are more likely to support this (52%) than residents of the GTA (31%).
- **Over half of Ontarians are concerned about the pandemic's effects on students' mental health** – More than one in two Ontarians are concerned (54%; 32% somewhat concerned) about the pandemic's effects on students' mental health, while over one in ten are somewhat not concerned (nine per cent) or not concerned (three per cent). Three per cent are unsure. Women are more likely to be concerned (60%) about this than men (46%).

Ontarians are almost twice as likely to say spending money on public education is a more important spending priority for the government than eliminating the deficit

- **Four in ten Ontarians are concerned about the pandemic's effects on teachers' and education workers' mental health** – Four in ten Ontarians are concerned (40%; 36% somewhat concerned) about the pandemic's effects on teachers' and education workers' mental health, while over two in ten are somewhat not concerned (13%) or not concerned (nine per cent). Three per cent are unsure. Women are more likely to be concerned (45%) about this than men (34%).
- **Ontarians are nearly two times more likely to say spending money on public education is a more important spending priority for the government than eliminating the deficit** – Fifty-one per cent of Ontarians say spending money on public education is a more important spending priority for the government, while 27 per cent say eliminating the deficit and paying down the debt is more important. Twenty-two per cent are unsure.

Nanos conducted a representative online survey of 2019 Ontarians, from June 23rd to 28th, 2020, drawn from a non-probability panel. The results were statistically checked and weighted by age and gender using the latest Census information and the sample is geographically stratified to be representative of Canada.

The research was commissioned by Ontario Public School Boards' Association and was conducted by Nanos Research.






























