Support Worker Programs

We are pleased to share that on April 27, 2021, the government announced funding for a one-time bursary for students participating in Personal Support Worker (PSW) programs delivered by district school boards across Ontario, as part of the provincial Long-Term Care Staffing Plan. This investment will support stabilization and expansion of school board PSW programs by providing comparable benefits as those being provided to students in publicly-assisted college delivered PSW programs.

Currently, 23 school boards offer PSW programs at 41 sites. In addition, there are some schools offering PSW certification through Specialist High Skills Major (SHSM) Health and Wellness programs. Eligible students could receive benefits of up to \$7,735. This includes up to \$2,000 to cover the costs of equipment, supplies and other mandatory fees, as well as a stipend in the amount of \$5,735 for their guaranteed work placement.

To be eligible for the financial support, students must either be currently enrolled in a full PSW program leading to certification as of September 2020, or must begin classes between April 1, 2021 and March 31, 2022. In addition to the work placement, PSW programs will offer experiential learning experiences early in the program, providing students with a better understanding of the requirements of a PSW career.

These funds will be administered through Transfer Payment Agreements with individual school boards that have PSW programs and will have appropriate reporting requirements on how funds are spent and distributed to students. Students must complete the program to benefit from the full financial support. The Agreement will also include funding to cover school board administrative costs. Ministry staff will be contacting PSW program leads at those school boards offering PSW programs to establish the Transfer Payment Agreements.

We would like to acknowledge the efforts of the Ontario Association of Adult and Continuing Education School Board Administrators (CESBA) for its support on behalf of school board PSW programs.
